Meeting Minutes

Future of AIR Committee Update

Adrea Hernandez noted that a presentation on ASAE's strategic foresight will occur at the October in-person Board meeting. The presenters are from associations other than ASAE who serve on the ASAE advisory committee.

Board Travel Stipend

Karen Vance shared an update on the pilot for the Board travel stipend for the 2024 Forum intended to support Board members from institutions that do not fund professional travel, up to \$750. Discussion included whether the program should be continued for the 2025 Forum, expanded to include NEC members, and/or expanded funding. It was noted that more financial projections are needed to determine what can be afforded within the budget and to fully explore scenarios. An open-ended allocation without a budget would not be sustainable. The Board agreed to pilot the stipend program for the 2025 Forum to include the NEC, with a cap of \$750 per person who requests assistance and demonstrate needs. The Board will explore the possibility of incorporating it into the governance policy in the future.
